I agree to waive the right to the use of my photos at the competition.

Release, Assumption of Risk, Waiver, and Indemnification
This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Competition, the New Heights Hunters & Jumpers, L.L.C. Horse Show to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longer, lessee, owner, agent, coach, trainer, or as a parent. I am fully aware and acknowledge that horse sports and the Competition involve dangerous risks of accident, loss, and serious bodily injury including broken bones, head injury, trauma, pain, suffering and/or even death (*Harm*).

I AGREE to release the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others. resulted directly or indirectly, from negligence of the Federation or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold harmless with respect to claims for Harm to me or my horse, and made by others for any Harm caused by me or my horse at the Competition.

I have read the Federation Rules about protective equipment, including GR318 and EV113, and I understand that I am entitled to wear protective equipment without penalty, encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to assume all of the obligations of this Release on the child's behalf.

I AGREE that "the Federation" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I AGREE that if I am injured in this Competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Competition on the official accident/injury report form.

I represent that I have the requisite training, coaching, and abilities to safely compete in this competition.

BY SIGNING BELOW, I AGREE to be bound by all applicable Competition Rules and all terms and provisions of this entry blank, as well as, I UNDERSTAND the Wisconsin State Statues regarding Equine Activities.
